## Directions to the Cantrell Home:

- I-5 North.
- 4<sup>th</sup> Street exit which is the first exit in Marysville.
- **Right** or east. 4<sup>th</sup> street turns into 64<sup>th</sup> street which will dead end at HWY 9.
- **Right** on HWY 9.
- **Left** on 60<sup>th</sup> or Lake Cassidy Road which is the very first left possible.
- **Left** on 54<sup>th</sup> which is the very first stop you come to.
- Shortly after crossing the Centennial Bike trail you will see the 110<sup>th</sup> Avenue and dead end sign on the left hand side of the road.
- **Left** on 110<sup>th</sup> Avenue for about a ½ mile, almost to the end.

The development is called **The Preserve at Lake Cassidy**.

We are the taupe/beige house on the right hand side directly across from the kid's play area.
